Competition Rules

Memberships

- USEF Membership: This is a USEF lite show. NO USEF memberships, non-member fees, or horse registrations are required to compete in this show except for the person signing as trainer who MUST be a USEF competing member and current on Safe Sport training (except if horse is only entered in opportunity classes). If you are interested in accumulating USEF Horse of the year points, provide the USEF number for horse, owner and rider. Shows are eligible for ½ USEF pts. Please provide your USEF number if you are a member.
- WDAA Memberships: All owners and riders competing to qualify for WDAA lifetime points MUST be a member of WDAA to be eligible for WDAA lifetime points program. You may learn more about the lifetime points program and about membership at www.westerndressageassociation.org. As a USEF "Lite" show, this show is eligible for DOUBLE WDAA lifetime points.
- AQHA Memberships: Those with AQHA membership who wish to qualify for AQHA awards are responsible for proper registration with AQHA to be able to earn points at this show. The show will submit \$10.00 to AQHA for each AQHA member; this is a required processing fee per AQHA horse/rider combination
- Opportunity class scores do count for KDEA annual awards program if rider is a KDEA member at the time the scores are earned. Score from opportunity classes do not count for USEF, WDAA, AQHA awards points. Check with your local club to see if opportunity classes count toward their awards program. No horse or rider memberships are required for opportunity classes this includes person listed as trainer. No USEF drug fee is paid.

Entries

- Negative Coggins (within the 12 months of the show date) and vaccination record (Equine Influenza Virus and Equine Herpes Virus "Rhinopneumonitis" within 6 months of show date) are required to be submitted with entry or shown prior to unloading on show grounds.
- Deadline: Entries must be received by the closing date. Make checks payable to Kansas Dressage and
 Eventing Association and send entry to Stacia Wert Gray, entry secretary. Credit cards through

- Online entry address is https://horseshowoffice.com/#/
- Every horse/rider team requires a separate entry. Entry must be complete before receiving packet.
- Riders MUST check in at the show office prior to schooling.
- **Multiple Riders**: Horses may be ridden by multiple riders and may be ridden at different levels, but a horse may not be entered in the same class even if ridden by a different rider.
- **Priority and Waitlists:** Entries are accepted as received by secretary. Entries may be limited. Entries arriving after closing will be accepted at the discretion of the show secretary as space allows. If the classes are oversubscribed, a "wait list" will be maintained. Horses will be moved into the show based on wait list order prior to schedule. After the show has been timed, show secretary will work wait list horses into the show based on the best fit. Management reserves the right to refuse any entry
- Horse, rider, owner USEF numbers are optional. If you are competing for USEF year-end awards, please provide these numbers.
- Horses Not Competing: Non-showing horses are allowed on the grounds if space is available. The
 owner must fill out an entry form and pay office, stall, and non-competing horse fees, but no USEF drug
 fee.
- Bridle Numbers: All horses (competing and non-competing) must wear show numbers when out of stall/away from trailer.

Tests and Level Restrictions

- Maximum tests per horse: Horses in this competition are limited to four tests per day.
- Level restrictions Horses may only compete in levels that are adjacent with the same rider. For
 example, a horse may not be ridden in a basic level test and a level 2 test unless with a different
 rider.
- **Tests**: Current WDAA/USEF tests are available at www.westerndressageassociation.org. Check to make sure you have the most recent version of the test (dated 2022).

Attire and Equipment

USEF rules and guidelines will be used for attire and equipment. Please visit www.usef.org and/or https://wdaa.memberclicks.net/assets/docs/WDAA%20Equipment%20and%20Attire%20Guide%204%205%202023.pdf

Note: Be sure to check the most recent version of this document a few weeks prior to the show date.

• Required Attire:

- Suitable western hat. Protective headgear may be worn without penalty (See GR801) and is STRONGLY recommended.
- Long-sleeved shirt with any type of collar: short sleeves may be worn at the discretion of the judge
- Trousers, pants, a one-piece long sleeved equitation suit provided it includes a collar.
- Boots with distinguishable heel.

Optional Attire:

- Necktie, kerchief, bolo tie or pin.
- A vest, jacket, coat and/or sweater.
- Spurs. Western style, with or without blunt tines, English dressage style, roller ball, and blunt bumper spurs are permitted. Rowels must be vertical. Spurs with sharp tines are not permitted.
- Chaps, shotgun chaps, chinks, armitas, or split riding skirt.
- Protective headgear is acceptable; not required to be of Western style. BOD 6/28/21
 Effective 12/1/21

Scheduling

- Management reserves the right to change officials, limit entries, combine or cancel classes, and modify
 the schedule to make any changes required by circumstances to the competition specifications listed
 herein
- Show Management reserves the right to cancel classes insufficiently filled and to refuse or require withdrawal of an entry for cause deemed sufficient by Show Management
- Musical freestyle sound check will be late afternoon (exact time with ride times) on June 14.

Official Ride Times

- **Provisional Ride Times:** Stabling assignments and provisional ride times will be available on www.horseshowconsulting.com/ about one week prior to the show. They will be emailed as well.
- Day Sheet: Be certain to check the day sheet which will be posted by noon the day before the show. It will reflect any last minute scheduling changes. The day sheet will be posted in the show office. The day sheet is the "Official Show Times" document.

Scores

- Tests will be scored in show office and scores will be posted on site. After the show, scores will be available on www.horseshowoffice.com.
- It is the responsibility of the competitor to verify the accuracy of all scores.
- Scoring errors must be reported to the Show Manager within one hour of the official posting of the scores from the last class of the show day during which the score was earned.

- Ties will not be broken.
- Each competitor is responsible for supplying management with correct applicable numbers
 (USEF/AQHA/WDAA) for horse, owner, rider, and trainer, before the day(s) of the competition. The
 scores of competitors who fail to supply correct numbers may not be counted toward national awards.

Facility Information

Stabling

- **Stalls:** Stalling is optional. 12 stalls, 10x10 in size, are available in indoor arena. Stall fee includes initial shavings. Floors are dirt.
- **Shavings:** Additional shavings are available for purchase through the show office prior to the show or during the show for \$10/bag. Alternately, you may bring your own shavings. Please, no straw bedding.
- Availability: Stalls are available from 3pm the day prior to the show until 9 pm on show day.
- Tack: Tack stalls are available for \$25.00 but they will have shavings/dirt in them, and will only be available if not needed for horse stalls.

Groups: Please note stalling groups with your entry. Show secretary is a lousy mind reader!

Arenas

- **Footing:** Outdoor competition arena is sand; warmup will be in the indoor arena with sand/dirt mix for footing.
- Arena Size: Small ring (20m x 40m) may be used for Introductory and Basic level tests. All other classes will be in the standard(20m x 60m) ring. All freestyles (including intro and basic level) will be in the 20m x 60m ring.
- Schooling
 - Horses may work in the warm-up and show arenas on Friday after 3:00 pm **Riders MUST check** in with the show office and obtain their number prior to schooling.
 - Hand walking in the indoor show arena on show day is permitted at designated times. Warm-up is outside on grass or in dirt arena: lunging is available in designated round pen only.

Accommodations

- Hotels: Hotels in SE Wichita are the closest to the facility.
- **RV:** Self contained RVs are welcome to park on the grounds, but no electrical or water/sewer hookup is available. Please make note on your entry that you will be staying on the grounds.

Other

- Dogs: Dogs are allowed on the grounds but must be on a non-retractable leash or restrained at all
 times. They are not allowed near the show ring or warm-up ring. They must be quiet and mannerly.
 Show manager may ask dogs to be removed for cause.
- Rain Plan: Warm up is inside. Show arena is outside. In the event of rain and footing becomes an issue, the show committee may place the show "on hold" until the rain passes or may move the show ring inside to the indoor arena which is 18.5 meters wide. Should rain become heavy or we experience lightening, we will allow the next 5 horses on the schedule to warm-up indoors for 15 minutes. Those horses will then ride their test. This will cause the show to run late. Listen to the announcements for updates on warm-up and ride times.
- Sharps Containers: Competition management shall place at least one sharps container in each stabling area for the disposal of needles and other disposable sharp instruments. Competition management may fine any individuals including trainers, owners, exhibitors or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. If local law has different requirements, local law prevails.
- Other: Every class offered herein which is covered by the rules and specifications of the current rules and of the current rulebook will be judged in accordance therewith.

A. RULES AND REGULATIONS: hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers.
