- **RETURNED CHECKS**: There will be a penalty of \$50 charged if a check is refused by the bank for any reason. No checks will be processed through the bank a second time and must be covered by a money order, cashier's check or cash, in addition to the penalty.
- REFUNDS/SCRATCHES: Scratches for entries prior to the closing date will receive a total
 refund of entry and stall fees minus the \$30 office fee. After the deadline entry fees are
 only refundable IF ACCOMPANIED by a veterinary certificate. NO STALL FEES OR
 BEDDING FEES WILL BE REFUNDED. Under no circumstances will any fees be refunded
 after the entry closing date without a veterinary certificate.

REGISTRATIONS:

AMHA REQUIREMENTS

- In AMHA Medal classes, riders are required to be a current Junior member of the American Morgan Horse Association
- O Morgan horses shown must be registered with the American Morgan Horse Assn. Inc., or the CLRC or the BMHS and must be entered under their full registered name and registration number, or if under one year of age, be eligible for registration. Horses must be entered under the names of the owner(s) or lessee of record with AMHA. A copy of the registration papers showing recorded ownership or proof of lease must be submitted with entry form at the time of entry. This only applies to horses competing in Morgan Designated classes.

USEF REQUIREMENTS

- o This show is licensed by USEF as a Competition Lite.
- Owners and riders are NOT required to be members of the Federation. Note: anyone with a current competing USEF membership over the age 18 must have completed the SafeSport Training prior to the first day of competition.
- Those signing as trainer on the entry form, must be a competing member of USEF and have completed SafeSport Training before the first day of competition.
- Drug fees are not charged this show, but any horse is subject to testing.
- Medication forms must be filed electronically.
- Lite Competitions will award half-value HOTY points to all USEF recorded horses, whose owner is a competing member.
- In Summary All entries MUST have a trainer listed. USEF competing membership is required for the person listed as trainer. Junior riders may not be listed as trainer. All trainers must be current on USEF SafeSport training!

- **AWARDS PROGRAMS**: For horses eligible for lifetime and year end high point awards from WDAA, AMHA, SSMHA or any other association please provide your horses registration numbers or any paperwork that is required of the show secretary.
- ALL BREED CLASSES: Rider/Driver/Handlers entered only in this section are exempt from the AMHA Non-Member fee. Entries are allowed to cross enter in other classes in this horse show provided the requirements are met for those classes. No same horse and rider combination can enter walk/trot/jog classes and walk/trot/jog/canter/lope classes and be judged in walk/trot/jog classes.
- **SHOW AGE:** Age of rider determined by age as of Dec. 1st 2023.

CLASS INFORMATION

- BUY-A-CLASS: Classes may be purchased for a sponsorship of \$35.00. After the class is bought, all entries pay the normal entry fee for the class including the person that bought the class. Please indicate on your entry blank which time slot you would like the class to be held (see schedule for available time slots). Show management reserves the right to arrange the schedule as they see fit. As classes are purchased, they will be posted to horseshowoffice.com
- CHANGE/SPLITS/CANCELLATION: Management has the right to combine, cancel or split any classes it deems appropriate. Management reserves the right to reschedule any class for the overall good of the show; exhibitors will be notified of such changes prior to the session starting. Morgan Classes that are labeled "17 and under" with more than 3 entries that fall into either "13 and under" or "14-17" in accordance to USEF age definition can be split into an A and B section. Walk-Trot classes with more than 10 entries are subject to split based on age.
- **JUDGING**: A single-judge system shall be used for all classes.
- **CLASS ANNOUNCEMENTS:** Please be aware class calls are a courtesy to the exhibitor. Show management is not responsible for an exhibitor missing a class.
- ATTIRE: All riders, drivers, and attendants entered in Morgan classes shall be neatly and suitably dressed upon entering the show ring. Riding suits are not required for entries entered in All Breed/Open classes. Jackets may be excused at the discretion of the judge in the event of extreme heat. Long sleeves must be worn by ridden Morgan entries.
- **HEADGEAR** Riders must wear ASTM/SEI approved headgear with properly fitting harness in the following:
 - Hunter Seat Equitation classes, including walk-trot.
 - Leadline riders at all times when mounted.
 - All riders in Academy classes.
 - ASTM/SEI approved headgear is required for dressage classes (DR 120 and GR801.6)
 - Protective headgear is acceptable in any other division or class without penalty
- **PRO-AM JACKPOT:** Show off the best of the best in our Jackpot classes! Open to all breeds and all ages. Winner receives 50% of total class entries, 2nd place 30% and 3rd place 20%.
- DISCLAIMER: Management reserves the right to change officials, limit entries, combine
 or cancel classes, and modify the schedule to make any changes required by
 circumstances to the competition specifications listed herein.

ENTRIES:

ENTRY PROCESS

- Entry and stall reservations must be accompanied with a check or money order, payable to the SOONER STATE MORGAN HORSE ASSOCIATION and mailed to: Show Secretary, Stacia Wert-Gray 3420 E. 40th Edmond, OK 73013. Alternately, online entry is available at https://horseshowoffice.com/#/events
- All entries must be made on the official entry blank, one owner per entry blank. Every exhibitor, rider, driver, handler, coach and trainer or his agent must sign an entry blank. In the case of a rider, driver or handler under the age of 18, a parent or guardian, or if not available, the trainer must sign an entry blank on the minor's behalf. Classes entered during the show require payment in full or an open check in the Show Secretary office. Changes in rider, driver or handler or added classes must be made in the show office at least 1 hour before the session starts.

DRESSAGE/WESTERN DRESSAGE RESTRICTIONS

- Maximum tests per horse: Horses in this competition are limited to four tests
- Level restrictions Horses may only compete in levels that are adjacent with the same rider. For example, a horse may not be ridden in a basic level test and a level 2 test unless with a different rider (western dressage only). English dressage horses may only compete in tests that are adjacent even if with a different rider.
- Tests: Current WDAA/USEF tests are available at usef.org.
 - Dressage tests are not recognized by USDF, do not count for USDF points or USEF HOTY points, and do not count scores or as qualifications.
 - Western Dressage tests do count for WDAA Lifetime program and earn ½
 point USEF HOTY points assuming appropriate registrations and memberships
 are recorded.
- **POST ENTRIES:** Post entry will be allowed for this show for All breed/Open classes. For those showing in Morgan Classes post entry is allowed (\$50.00 post entry fee/horse).
- HORSES NOT COMPETING: Non-showing horses are allowed on the grounds if space is available. The owner must fill out an entry form and pay office and stall charge.
- **CHECK IN:** Riders MUST check in at the show office prior to schooling.
- **NUMBER:** A number will be assigned to each horse/rider at the time the entry is received. That number will stand for the entire show and must be displayed whenever the horse is in the ring. A bridle number will also be provided to horses competing in dressage/western dressage. Those horses must display a number whenever out of the stall. DR121.19 Competitors may use their own numbers for schooling (and competition) but they can't skip check-in just because they don't need to pick up a number. Failure to check in at the show office prior to schooling will result in the issuance of a Warning Card.

STABLING, VET, FARRIER AND ARENA INFORMATION

- **SECURITY:** Please note that security is provided at the facility between the hours of 10pm and 7 am.
- **FACILITY DIRECTIONS**: From I-44, take exit 83 (US HWY 62) and head west for 1.3 miles. Grady County Fairgrounds is located on the south side of HWY 62.
- **GPS ADDRESS:** 500 E Choctaw Ave, Chickasha, OK 73018
- **FEED & BEDDING**: All stalls are new 10x10 stalls with asphalt floor. Bedding must be purchased through the show at \$10/bag. Outside bedding is not allowed. Purchase bedding on the entry blank. Stalls DO NOT include initial shavings.
- **ARRIVALS:** Horses will be allowed onto the show grounds, and stalls will be available Thursday, September 5.
- **EARLY ARRIVAL:** Early arrival is available for Wednesday, September 4. Cost is \$25/stall.
- ARENAS: Indoor Show Arena dimensions are 120'x240'; Event Center 125'x300'.
 Footing in all the rings is sandy loam.

HEALTH REQUIREMENTS

- **COGGINS:** All horses must be accompanied by a record of a negative test for Equine Infectious Anemia (Coggins) conducted within the previous 12 months.
- **HEALTH CERTIFICATE:** All out-of-state horses must be accompanied by an interstate health certificate dated within 30 days.
- **VACCINATIONS:** At Federation licensed competitions, horses more than seven months of age must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to the show.

OTHER ISSUES

- **FOOD SERVICE**: A concession state will be available on the grounds.
- **STALLIONS:** No stallions are allowed to participate in classes with junior competitors. Impolite stallions will be asked to leave.
- **DOGS:** Dogs are allowed on the grounds but must be on a leash or restrained at all times. They are not allowed near the show ring or warm-up ring. They must be quiet and mannerly. **Dogs not in compliance will be asked to leave.** In Summary, Dogs are not permitted to be loose on competition grounds and must be held on a leash or otherwise restrained. Individuals must not lead dogs on a leash while mounted. Dog owners are solely responsible for any damages, claims, losses or actions resulting from their dog's behavior. Dog owners failing to comply with this rule will be issued a Yellow Warning Card and may be subject to penalty under Chapter 7. (GR1301.6)
- **RULEBOOK:** Every class offered herein which is covered by the rules and specifications of the current rules and of the current rulebook will be judged in accordance therewith.

 ACTS OF GOD POLICY: Management reserves the right to cancel any classes due to hazardous weather, Acts of God, accidents, or emergencies. Every effort will be made to reschedule with priority given to any qualifying classes.

USEF RULES & REGULATIONS

This show is licensed by USEF as a Competition Lite.

- Owners and riders are not required to be members of the Federation. Note: anyone with a current competing USEF membership over the age 18 must have completed the SafeSport Training prior to the first day of competition.
- Anyone signing as trainer on the entry form, must be a competing member of USEF and must have completed the SafeSport Training prior to the first day of competition.
- Drug fees are not charged at a Competition Lite show, but any horse may be tested.
- Medication forms must be filed electronically.
- Lite Competitions will award half-value HOTY points to all USEF recorded horses, whose owner is a competing member.

This Horse Show is conducted in accordance with the Rules of the USEF. The official Federation rulebook will prevail for this show. Each participant in this show is responsible for knowledge of these rules and is subject to these rules. Any changes or corrections of the rules will automatically become part of this prize list. Questions that may arise that are not covered by the USEF rulebook will be decided by the Show Committee and their decisions will be final. All Breed/Academy classes are not USEF recognized.

FEDERATION ENTRY AGREEMENT By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulter or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of the competition. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cablecasts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

SHARPS DISPOSAL

Safe and proper sharps disposal (needles, syringes and other hazardous objects and materials) is the responsibility of individual stables. Containers are available and will be properly disposed of by competition personnel when full.

GOLF CARTS

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

RESPONSIBILITY: Every entry for competition will be under control of the Sooner State Morgan Horse Association Fall Festival and the horse show management, but in no way shall Sooner State Morgan Horse Association Fall Showcase, and/or its owners, officers, directors, agents, employees, volunteers or personnel, be responsible for any loss, personal injury or damage to any horse exhibited, or for any article of any kind or nature that may be lost, destroyed or in any way damaged that may occur- even if the harm occurred as a result of the negligence of Sooner State Morgan Horse Association Fall Festival, and/or its owners, officers, directors, agents, employees, volunteers or personnel. It shall be a condition of entry that each Exhibitor expressly assumes all risk of harm (including death or destruction) to him or herself and/or his or her agent, employees, associates, children, animals, or personal property. It shall also be a condition of entry that each Exhibitor shall hold Sooner State Morgan Horse Association Fall Festival and its owners, officers, directors, agents, employees, volunteers and personnel; Grady County Fairgrounds; and its officers, directors and employees; and AMHA blameless for any injury, loss or accident to his or her person or property, including his/her horse and equipment.
